CHANGES TO PROJECT MANUAL:

- 1. Section 00-7300 Supplementary Conditions, Paragraph 1.02, A, 2: REPLACE "coducments" with "documents."
- 2. Section 00-7300 Supplementary Conditions, Paragraph 1.02, C, 2a: ADD "2) Contractor is required to obtain a current City of Florence Business License prior to commencing work." See attached Business License Form for reference.
- 3. ORS 279C Requirements for Public Works, Paragraph 13, b: After, "The latest prevailing wage rates for public works contracts in Oregon are contained in the following publications," REPLACE "July 1, 2022" with "January 5, 2023."
- 4. Section 06-2000 Finish Carpentry: ADD attached Section 06-2000 Finish Carpentry.
- 5. Section 07-4623 Wood Siding: ADD attached Section 07-4623 Wood Siding.

CHANGES TO DRAWINGS:

- Sheet A1.1 Site Plan, note: After "Sawcut (E) concrete walk & replace 30'-tall flagpole. Patch back concrete to match, flush w/ existing walk," ADD "remove and put back (E) plaque at concrete, adjacent to flagpole."
- 7. **Sheet A2.1 Floor Plan, note:** After "Mechanical/dumpster enclosure, prep and paint same as main field (P1)," DELETE "both sides" and REPLACE with "outside only. Trim to remain white. Remove and put back (E) mural artwork."
- 8. Sheets A4.1 A4.4 Elevations, General Notes: ADD: "6. Temporarily remove and put back (E) building accessories, such as trash receptacles and benches, to facilitate work. Remove wooden bench at northeast building entry; owner to replace."

1.04 ADMINISTRATIVE REQUIREMENTS

- A. Coordinate the work with installation of associated and adjacent components.
- B. Protect work from moisture damage.

PART 2 PRODUCTS

2.01 LUMBER MATERIALS

A. Softwood Lumber: Resawn texture cedar, K.D., grade C and better, maximum moisture content of 6 percent; primed, fingerjointed, 20 foot lengths, size as noted on drawings, S4S.
 1. Location: Fascias, window jambs, and as noted on drawings.

2.02 ACCESSORIES

A. Wood Filler: Solvent base, tinted to match surface finish color.

2.03 FABRICATION

- A. Shop assemble work for delivery to site.
- B. When necessary to cut and fit on site, provide materials with ample allowance for cutting. Provide trim for scribing and site cutting.

PART 3 EXECUTION

3.01 INSTALLATION

A. Set and secure materials and components in place, plumb and level.

B. Carefully scribe work abutting other components, with maximum gaps of 1/32 inch. Do not use additional overlay trim to conceal larger gaps.

3.02 PREPARATION FOR SITE FINISHING

- A. Set exposed fasteners. Apply wood filler in exposed fastener indentations. Sand work smooth.
- B. Site Finishing: See Section 09-9113.

3.03 TOLERANCES

- A. Maximum Variation from True Position: 1/16 inch.
- B. Maximum Offset from True Alignment with Abutting Materials: 1/32 inch.

1.01 SECTION INCLUDES

A. Wood siding with boards for walls.

1.02 RELATED REQUIREMENTS

- A. Section 06-2000 Finish Carpentry: Exterior wood trim at windows.
- B. Section 06-6500 Simulated Wood Trim
- C. Section 07-2500 Weather Barriers: Water-resistive barrier under siding.
- D. Section 07-6200 Sheet Metal Flashing and Trim: Product requirements for metal flashings and trim associated with wood siding for placement by this section.
- E. Section 09-9113 Exterior Painting: Prime and finish painting.

PART 2 PRODUCTS

2.01 PERFORMANCE REQUIREMENTS

A. Comply with local wind load resistance requirements of ASCE 7.

2.02 WOOD SIDING MATERIALS

- A. Board Siding: Beveled, cedar, maximum moisture content of 6 percent, K.D., grade A and better, clear.
 - 1. Size: 3/4" x 10", random lengths.
 - 2. Exposure: 8 1/8", match existing
 - 3. Surface Texture: Rough sawn.

2.03 ACCESSORIES

A. Nails: Corrosion resistant type; nonstaining, of size and strength to securely and rigidly retain the work.

PART 3 EXECUTION

3.01 INSTALLATION

A. Install siding in accordance with manufacturer's instructions.

- B. Fasten siding securely in place, level and plumb.
 - 1. Arrange for orderly nailing pattern.
 - 2. Install siding for natural shed of water.
 - 3. Position cut ends over bearing surfaces, and sand cut edges smooth and clean.
- C. Install board siding using single course method.
 - 1. Nail at 12 inches on center.
 - 2. Miter horizontal joints tight at 45 degrees, miter external and miter internal corners.
- D. Seal exposed wood substrates exposed to weather to prevent water accumulation and moisture intrusion.
 - 1. Seal penetrations.
 - 2. Seal exposed cuts of siding and trim; use of field-applied coatings is not permitted.
- E. Sand work smooth and set exposed nails and screws.
